APPLICATION RATES

For best results, apply twice a month as a foliar spray early in the morning, or late in the day. Allow foliar sprays to dry thoroughly before irrigation to insure even foliar uptake.

For Warm or Cool Season Turfgrasses

MAINTENANCE: Apply BRANDT CONVERGE 18-3-6 at the rate of 4 oz. per 1,000 square feet or approximately 1.25 gal. per acre.

RENOVATION: Apply BRANDT CONVERGE 18-3-6 at the rate of 6 oz. per 1,000 square feet, or approximately 2 gal. per acre.

Overseeding

Apply BRANDT CONVERGE 18-3-6 at least semi monthly after seeds have begun to germinate at the rate of 8 oz. per 1,000 square feet or 2.5 gal. per acre.
