General Information

BRANDT SEQUESTAR RMX-8 is recommended for crops such as alfalfa, almonds, avocados, apples, broccoli, cabbage, cauliflower, carrots, celery, citrus, corn, grapes, lettuce, milo, melons, nectarines, peaches, pears, pecans, peppers, plums, prunes, potatoes, sorghum, sugar beets, sweet corn, sugar cane, strawberries, tomatoes, turnips, walnuts, watermelons, wheat and most other crops.

This product gives best results when crops have adequate supplies of water and major nutrients, and are not under stress for other reasons. Conditions which are responsible for one particular deficiency can also induce deficiencies of other trace elements.

Directions For Use

Mixing: BRANDT SEQUESTAR RMX-8 is soluble in water. This product should be added slowly to the main bulk of the water while it is being agitated. Agitation should continue for a minute or two after the addition of this product. If pesticides are to be used with the spray mix, add them after the BRANDT SEQUESTAR RMX-8 has dissolved.

Compatibility: If the desired combination of fertilizers or pesticides has not been previously used, a compatibility test is recommended.

Soil Application: BRANDT SEQUESTAR RMX-8 is recommended for use on all types of soils. To ensure uniform coverage, this product should be dissolved in water or fluid fertilizer, or dry blended with water soluble fertilizers for band, sidedress, or broadcast applications. Soil applications may also be made by dissolving in water and then mixing or metering into drip, sprinkler or furrow irrigation systems.

Fruit Trees:	1 or 2 pounds per tree.
Vines:	0.5 to 1 pound per 100 feet of vine row.
Field Crops:	Up to 15 pounds per acre.
Row Crops:	Up to 15 pounds per acre.

The rates given in the table above are based on broadcast application. If broadcast rates are used for spot or banded applications, phytotoxicity may result.

Aerial Application: Apply 1/3 pound of BRANDT SEQUESTAR RMX-8 per acre in at least 10 gallons of water. For application timing and frequency, refer to appropriate foliar application recommendation.

Foliar Application: Foliar sprays of BRANDT SEQUESTAR RMX-8 are intended to complement good soil fertility programs by supplying nutrients directly to the foliage of crops during critical growth stages. Foliar soluble sprays may improve absorption and efficiency of micronutrient uptake. For maximum effect from any foliar spray, apply during morning or late evening, not in bright sunshine.

Fruit Trees:	0.5 to 1 pound per acre.
Vegetables:	0.5 to 1 pound per acre.
Row Crops:	0.5 to 1 pound per acre.
Ornamentals:	1 tsp. per gallon of water every 2 to 4 weeks. Use enough solution to cover thoroughly or approximately 1 gallon per 10 square feet. This product can be incorporated into NPK fertilizer at 4 oz. per 50 lbs. of NPK.
Turf - Greens:	Apply 1/2 to 1 lb. per acre in a minimum of 100 to 200 gallons of water. Best results will be seen where product is applied in early spring when greens are actively growing. Four or more applications may be made at monthly intervals to help maintain vigor and color. Applications should always be made later in the evening or early in the morning to reduce potential for phytotoxicity.
Turf - Fairways:	Apply 1 lb. per acre in a minimum of 40 gallons of water. Use three or more applications per year to maintain fine healthy turf.

Caution: Multiple chelate applications should be made at no less than 10 to 14 day intervals to reduce the potential for crop injury.

Do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rain is expected. Apply this product only to your lawn/garden, and sweep any product that lands on the driveway, sidewalk, or street, back onto your lawn/garden. Check with your local Cooperative Extension Agency to obtain specific information on local turf best management practices.
