Directions for Use

Apply recommended dosage from chart above in a minimum of 2 gallons per 1000 sq ft or 100 gallons of water per acre. More reliable results are obtained with lower, more frequent applications. Irrigate before next mowing or leave clippings on ground. When applied with pesticides and fertilizers, test spray mixtures in a small area before full-scale application. User needs to use caution and good judgment when using this and all other turf care products to avoid injury or serious damage. Seed establishment - add 4 oz. per 1000 sq ft two weeks before seeding.

Brandt Topcoat

BRANDT TOPCOAT may be used in many different situations and under any conditions where the improvement of ability of water to penetrate soil is necessary or desired. This can include new plantings such as for decorative trees, bushes or flowers. Also included are various needs for turfgrass such as the treatment of problem and disease areas due to the inability of water to penetrate the ground such as Localized Dry Spot or LDS.

Applications may be made pre-plant, at plant and/or post-plant to improve water content of the soil. Also, BRANDT TOPCOAT may be used in hydroseeding mixtures to improve water content of the blend. BRANDT TOPCOAT may also be used to treat problems caused by the inability of moisture to penetrate the soil in a Localized Dry Spot (LDS).

FIRST AID

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth if possible. Call a poison control center or doctor for further treatment advice.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage or disposal.

STORAGE: Store in a cool, dry, locked area out of reach of children. Protect from excessive heat. Keep container tightly closed in storage to prevent entry of water.

PESTICIDE DISPOSAL: Waste resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

CONTAINER DISPOSAL: Triple rinse (or equivalent). Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by incineration, or if allowed by state and local authorities, by burning. If burned, stay out of smoke.
