General Information

BRANDT SESAMIN EC is a naturally derived soil amendment to enhance the growth and health of all field, row, vegetable, fruit, tree and vine crops, and turf and ornamentals.

Rate Recommendations

Use higher rate on sandy soils and on plants under stress. Repeat applications as needed during active growth cycle.

Apply 4-10 liters per hectare using sufficient volume of water to achieve desired coverage. For smaller areas, mix 10-20 mL per liter of water (1-2% solution) and apply at the base of the plants and the surrounding area (at least 0.5 meter diameter beyond the plant base). Spray until soil or ground cover is moist; do not over saturate.

For plants with deep root systems (ie. trees, shrubs, etc.) apply recommended rate during the last third of the irrigation cycle.

Do not apply this product when the soil has become saturated with water or when rain is expected on the day of treatment. Do not irrigate until the evening after treatment.

Mixing and Handling Instructions

SHAKE WELL BEFORE USING. Put 1/3 to 2/3 of total required water volume in tank. Add adjuvants, fertilizers and pesticides if desired and agitate until thoroughly mixed.

Add recommended amount of BRANDT SESAMIN EC and agitate until mixed. Fill tank with remainder of water.

This product is compatible with most NPK fertilizer solutions and pesticides targeting the same root zone. A jar test is a good field practice for evaluating compatibility of multiple chemical mixtures. Avoid mixing with soil wetter/surfactant chemistries and with pesticides that require excessive watering in, as this may cause BRANDT SESAMIN EC to be pushed below the root zone.

Storage and Handling

Store in original container in a cool, dry area out of reach of children. Avoid excessive heat and freezing temperatures. Keep container tightly closed during storage. Do not reuse container. Triple rinse container thoroughly and offer for recycling if available, or dispose of in accordance with local, state & federal regulations.

CAUTION: KEEP OUT OF REACH OF CHILDREN

Good safety practices are recommended, such as avoiding contact with eyes and skin. If product gets in eyes, flush with plenty of water. If on skin, wash thoroughly with soap and water. If irritation persists, contact a physician.
