General Information

Although formulated specifically for citrus, this product may be used on all field, row, vegetable, fruit, tree, vine and ornamental crops for the prevention and correction of micronutrient deficiencies.

Rate Recommendations

Apply 5-15 liters per hectare by ground or 1.5-3 liters per hectare by air. At least 2 applications are recommended. More frequent applications of 5 liters per hectare may be needed to correct deficiencies once they occur.

Optimum rate of application will vary depending on soil properties (such as pH, organic matter content, texture), weather conditions, time of year, general crop health and

crop species. For best results, follow soil test or plant analysis recommendation.

WARNING: This product is recommended for all crops where boron may be deficient; however overapplication may result in serious injury to susceptible crops.

Mixing and Handling Instructions

Apply in a minimum of 100 liters water per hectare for ground spray equipment or 20 liters water per hectare for aerial application. This product may also be applied via drip or sprinkler fertigation.

Put 1/3 to 2/3 of total required water volume in tank. Add adjuvants, fertilizers, and pesticides if desired and agitate until thoroughly mixed. Add recommended amount of this product and agitate until thoroughly mixed. Fill tank with remainder of water.

Caution: Check chemical mixture compatibility using a jar test prior to application. Be cautious when mixing with phosphate solutions.
