General Information

READ LABEL BEFORE USE

BRANDT MANNI-PLEX Ca is designed for application to field, row, vegetable, fruit, tree, vine and ornamental crops for the prevention and correction of calcium deficiency when used as part of a balanced fertility programme.

Rate Recommendations

Field, Row, Vegetable, Fruit, Tree and Vine Crops:

Apply 2-5 litres per hectare per application throughout the growing season. At least 2 applications are recommended. More frequent applications of 3.5 litres per hectare may be needed to correct deficiencies once they occur. For pre-plant or sidedress applications, use 8-20 litres per hectare.

Ornamental Crops: Apply 250-500 mL per 100 litres water. Cover foliage thoroughly to point of runoff.

Optimum rate of application will vary depending on soil properties (such as pH, organic matter content,

texture), weather conditions, time of year, general crop health and crop species. For best results, follow soil test or plant analysis recommendation.

Mixing and Handling Instructions

Apply in a minimum of 100 litres water per hectare for ground spray equipment or 20 litres water per hectare for aerial application. BRANDT MANNI-PLEX Ca may also be applied via drip or sprinkler fertigation.

Put 1/3 to 2/3 of total required water volume in tank. Add adjuvants, fertilisers, and pesticides if desired and agitate until thoroughly mixed. Add recommended amount of this product and agitate until thoroughly mixed. Fill tank with remainder of water.

Caution: Check chemical mixture compatibility using a jar test prior to application. Be cautious when mixing with phosphate solutions.

For low volume spraying, use a wetting agent such as Du-Wett® Super Spreader for best deposition and coverage. Follow adjuvant label for correct use rates.
