## General Information

BRANDT K is designed for application to all field, row, vegetable, fruit, tree and vine crops, and turf and ornamentals for the prevention and correction of potassium deficiency when used as part of a balanced fertility program.

## Rate Recommendations

### Field, Row, Vegetable, Fruit, Tree and Vine Crops:

Apply 1-5 quarts per acre per application throughout the growing season. For pre-plant or sidedress applications, use 1-4 gallons per acre.

**Ornamental Crops:** Apply 1-2 quarts per 100 gallons water. Cover foliage thoroughly to point of runoff.

**Turf:** For best results apply early morning or late evening.

*Green & Tees:* 2-5 fl.oz. per 1,000 sq.ft.

*Fairways & Sports Turf:* 2-7 quarts per acre.

*Overseeding:* 2 fl.oz. per 1,000 sq.ft. after germination.

*Sod Installation:* 2 fl.oz. per 1,000 sq.ft. at installation.

Optimum rate of application will vary depending on soil properties (such as pH, organic matter content, texture), weather conditions, time of year, general crop health and crop species. For best results, follow soil test or plant analysis recommendation.

## Mixing and Handling Instructions

Apply in a minimum of 10 gallons water per acre for ground spray equipment or 2 gallons water per acre for aerial application. For turf applications, apply in a minimum of 1 gallon water per 1,000 sq.ft. BRANDT K may also be applied via drip or sprinkler fertigation.

Put 1/3 to 2/3 of total required water volume in tank. Add adjuvants, fertilizers and pesticides if desired and agitate until thoroughly mixed. Add recommended amount of BRANDT K and agitate until thoroughly mixed. Fill tank with remainder of water.

Caution: Check chemical mixture compatibility using a jar test prior to application. BRANDT K has an alkaline pH and may not be compatible with pesticides that degrade in alkaline conditions.
