General Information

BRANDT FLASH DANCE is designed for an instant greening effect prior to tournament play. Applied foliarly, this product will initiate an immediate greening effect triggered by the highly soluble sulfate form of iron. BRANDT FLASH DANCE is safe for use on all fine turfgrasses when used as part of a balanced fertility program.

Rate Recommendations

Use 3 fl. oz. per 1,000 sq. ft. of turf. At least two applications are recommended, especially if clippings are removed. Use a minimum of one gallon of water per 1,000 sq. ft. to ensure adequate coverage.

Turf (Commercial): Apply only to actively growing turf. For best results, apply early morning or late evening.

Optimum rate of application will vary depending on soil properties (such as pH, organic matter content, texture), weather conditions, time of year, general crop health and crop species. For best results, follow soil test or plant analysis recommendation.

Mixing and Handling Instructions

Apply in a minimum of 10 gallons water per acre for ground spray equipment or 2 gallons water per acre for aerial application. This product may also be applied via drip or sprinkler fertigation.

Put 1/3 to 2/3 of total required water volume in tank. Add adjuvants, fertilizers, and pesticides if desired and agitate until thoroughly mixed. Add recommended amount of this product and agitate until thoroughly mixed. Fill tank with remainder of water. Check chemical mixture compatibility using a jar test prior to application.

Do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rains are expected. Apply this product only to your lawn/garden. Check with your local Cooperative Extension Agency to obtain specific information on local turf best management practices.
