General Information

BRANDT 11-8-5 provides highly available plant food for foliar feeding and is compatible with most pesticides for combination spraying. It is primarily intended to stimulate early season plant growth. Follow recommendation of local agricultural authorities for specific rates and timing.

Rate Recommendations

Field, Row, Vegetable Crops: Apply 1-2 quarts per acre in at least 20 gallons water per acre for ground sprayers or 3 gallons for aircraft. Repeat as needed.

Fruit, Tree and Vine Crops: Apply 2 quarts per acre in at least 100 gallons water per acre with conventional sprayers, 40-100 gallons with concentrate sprayers, or 10 gallons for aircraft. Repeat as needed. On waxy foliage or smooth skinned fruit, add sufficient spreader for smooth wetting to avoid spotting.

Turf and Ornamentals: Apply 1-2 quarts per acre (0.75-1.5 fl.oz. per 1,000 sq.ft) in sufficient water for thorough coverage. Repeat as needed.

Optimum rate of application will vary depending on soil properties (such as pH, organic matter content, texture), weather conditions, time of year, general crop health and crop species. For best results, follow soil or plant tissue test recommendation to monitor specific levels of nutrients and maintain these levels for optimum plant growth.

Mixing and Handling Instructions

Put 1/3 to 2/3 of total required water volume in tank. Add adjuvants, other fertilizers and pesticides if desired and agitate until thoroughly mixed. Add recommended amount of BRANDT 11-8-5 and agitate until mixed. Fill tank with remainder of water. Check chemical mixture compatibility using a jar test prior to application. Make test applications on a few plants if using combinations not known to be safe. To avoid phytotoxicity, do not apply with copper or lime-sulfur fungicides, or during bloom.
