Rate Recommendations

FOLIAR APPLICATION

Field, Row, Vegetable Crops: Apply 1/2-2 pints per acre in sufficient spray volume for thorough coverage (minimum of 10 gallons for rate ≤1 pt.; 25 gallons for rate >1 pt).

Fruit, Tree, Vine Crops: Apply 1 1/2-3 pints per acre in a minimum of 25 gallons water. For smooth skinned fruit apply 1 pint per acre in 50-100 gallons of water.

Citrus: Apply 1 1/2-3 pints per 100 gallons of cover spray any time except during bloom.

Aerial: Apply 1 pint per acre in at least 5 gallons of water.

SOIL APPLICATION

All crops: Apply 1-3 quarts per acre.

Treating sensitive crops such as leafy greens and soft skinned fruits during periods of high temperatures may result in cosmetic injury. Avoid applying this product when plants are suffering from moisture stress. Apply the spray solution to a small test area of the crop or foliage to assess any undesirable effects or phytotoxicity before general application.

Put 1/3 to 2/3 of total required water volume in tank. Add adjuvants, fertilizers, and pesticides if desired and agitate until thoroughly mixed. Add recommended amount of this product and agitate until thoroughly mixed. Fill tank with remainder of desired water.

The use of an adjuvant is recommended. Performing trials with adjuvants may be useful in determining the best inclusion rates for optimal performance. Check chemical mixture compatibility using a jar test prior to application.
