For best results apply as a foliar spray early in the morning or late evening. Allow to dry on plant 3-6 hours before irrigation.

**COOL SEASON TURF GRASSES:** Apply 1-3 fl. oz. per 1000 sq. ft. Repeat as needed.

**WARM SEASON TURF GRASSES:** Apply 2-6 fl. oz. per 1000 sq. ft. Repeat as needed.
