### GREENPIG™ USAGE RATES

**Cool Season Turfgrass - Putting Greens (Maintenance Rate) with 50-100 Gallon of Water**  
10-14 oz per Acre • 7-10 ml per 100 Meters Sq. • 660 ml - 1 liter per Hectare

**Cool Season Turfgrass - Fairways (Maintenance Rate) with 50-100 Gallon of Water**  
14-18 oz per Acre • 10-12 ml per 100 Meters Sq. • 1-1.25 liters per Hectare

**Warm Season Turfgrass (Maintenance Rate) with 50-100 Gallon of Water**  
14-24 oz per Acre • 10-15 ml per 100 Meters Sq. • 1.5 liters per Hectare

*Spot test for acceptable color depth prior to full scale spraying. Adjust rates as needed. Retain mix rate records as a reference for future spray applications. To insure optimal spray equipment performance, use a quality tank cleaner and upgrade to Teflon pump seals. Thoroughly clean spray equipment after use. Avoid over spray where colorant is not desired or staining may occur. Dispose of empty container according to local and state sanitation laws.*
