**Cool Season Turfgrass - Putting Greens (Maintenance Rate) with 50-100 Gallon of Water**  
1.5 - 3.0oz / M

Do NOT use on dormant or semi-dormant turfgrass  
Contains proprietary UV blocking compound  
Do NOT use on drought stressed turfgrass

*Spot test for acceptable color depth prior to full scale spraying. Adjust rates as needed. Retain mix rate records as a reference for future spray applications. To insure optimal spray equipment performance, use a quality tank cleaner and upgrade to Teflon pump seals. Thoroughly clean spray equipment after use. Avoid overwatering where colorant is not desired or staining may occur. Dispose of empty container according to local and state sanitation laws.*
